Thank you for your interest in addressing the members of the legislative delegation at the upcoming public hearing.

You are on the agenda to address the delegation at the hearing on Tuesday, October 17, 2017 at the Solid Waste Authority Administration Building in the auditorium located at 7501 North Jog Road, West Palm Beach, FL 33412. The hearing will be held from 9:00 am to 12:00 pm.

The delegation is interested in making this process as expeditious as possible and allowing your organization the best opportunity for legislative success.

The day you present your proposal or idea to the delegation, you are taking the opportunity to briefly update the entire assembled delegation of your ideas. You will have **three minutes** to address the delegation, and afterward they may ask you questions.

Keep in mind, however, any appropriation request, local bill, or general legislation must have a member (or members) of the legislature sponsor and introduce it. It is your responsibility to obtain this sponsorship prior to your hearing date.

If you have not obtained a legislative sponsor by the date of your presentation, you must locate one willing to do so as soon as possible after your hearing. <u>It is not the Delegation's responsibility to assign sponsors.</u>

If you are submitting a local bill request, it is your responsibility, along with that of your legislative sponsor to complete and submit the required documents, including the 2018 Economic Impact Statement form, and adhere to public advertising requirements in a timely manner.

It is important to remember that an appearance at a delegation hearing <u>does not ensure</u> that your bill or request will be filed. You <u>must</u> obtain a commitment from a legislator before your request will be acted upon.

All presenters, including those scheduled to make **public comments**, MUST comply with the following:

- Because of our limited time constraints and the number of presenters, speakers are strictly limited to **three minutes** for their presentation.
- When your three minutes have expired, a tone will sound at which time the Chair will thank you for your comments and recognize any questions or statements from the delegation members.

Please prepare your remarks to fit within these time constraints.

We hope these guidelines will assist in your understanding of this process.

We look forward to your briefing and are pleased that you have taken the time and initiative to participate in the legislative process.

I-95

Take I-95 to Blue Heron Boulevard and head west. Merge onto the Beeline Highway. At the second light at N. Jog Road, make a left. The Administration Building entrance will be on the right or west side of N. Jog Road, after the Ironhorse community. SWA Administration Building: **7501 N. Jog Road, West Palm Beach, FL 33412**

TURNPIKE (SUNPASS ONLY)

Take the Florida Turnpike to Exit 107 S.R. 710/ Beeline Highway. At the light, turn left onto N. Jog Road. At the next light, go straight to stay on N. Jog Road. The Administration Building entrance will be on the right or west side, after the Ironhorse community.
